



FACT SHEET GRANTS FOR GROUPS

Grants are an extremely valuable source of funding for Scout Groups.

Grant programs are run by all levels of government (local, state and federal), business (eg. ANZ, NAB, RACV, Bendigo Bank) and Philanthropic Trusts and Foundations. Government and business grants are the most relevant to Scout Groups.

Scouts Victoria has prepared this Fact Sheet to outline the opportunities that exist, the legalities and information that applies plus the processes involved – from the grant application to final acquittal for successful funding.

Essential information – MUST READ

- Scouts Victoria is the legal entity and registered not-for-profit organisation with tax Deductible Gift Recipient status (DGR) attached to our ABN, not individual Scout Groups.
- For successful grant funding, the funding bodies require tax invoices directly from Scouts Victoria in recognition of our formal registrations and tax status; and also require Funding Agreements to be signed by the legal entity, Scouts Victoria.
- Therefore all grant applications by Groups/Formations must be endorsed/auspiced by Scouts Victoria in the first instance and any successful funding must be deposited in to the Scouts Victoria bank account after which it is made available to the group (so it can be receipted).
- Please note if the purpose of the funding is to contribute towards the cost of internal or external
 works to the Scout hall site, prior Property Committee approval may be required before submitting
 the grant. Please contact property department at property@scoutsvictoria.com.au to discuss and
 obtain assistance. Works such as painting and minor repairs would not generally require prior
 approval.

Process for successful grants:

Funding	In the event of a successful grant application outcome, as Scouts Victoria is the legal
agreement	entity, the Funding Agreement will need to be drawn up between the funding body
	and Scouts Victoria and as such signed by Scouts Victoria, not a Group representative.
	We will forward a final and signed copy of the Funding Agreement to the Group which
	needs to be carefully read and understood before the Group commences the project.
	Failure to follow the funding agreement could result in the funding being withdrawn.
Record keeping,	Most funding bodies have strict requirements as included in the Funding Agreement.
photographs	Most of these are the direct responsibility of the successful Group. These can include
	keeping receipts for X amount of time, spending money by a certain date, sending
	photographs at certain stages and so on.
Incoming funds	Successful grant funding must be deposited in to the Scout Victoria bank account in
and tax invoices	the first instance so a tax invoice can be issued to the funding body under the Scouts
	Victoria ABN. See bank account details above.
Expending funds	Once the funds are deposited into the Scouts Victoria bank account and the tax
	invoice is issued to the funding body, the amount is then available for the
	Group/Formation to spend the funding as per the funding agreement.
	This is done via the Accounts Team at Scouts Victoria through the following options:
	1. Provide a copy of the invoice to the account team for payment in advance to
	the supplier.
	2. Provide a copy of the receipt for purchases made for reimbursement to the
	Group's bank account.
	The Accounts Team will record each expense in the accounting software Xero so a
	balance can be obtained at any time.

Project Timeline	Add dates as to when you expect the project to start and finish. Ensure that you check
	the Grant Guidelines to confirm that they comply with these guidelines. If you require
	further time to complete the project you will need to advise the Funding Corp in
	writing.
Acquittals	Most funding bodies also have acquittal requirements often in the form of a Final
	Report (and/or progress reports) outlining benefits/outcomes to youth from funding
	and sometimes photographs. The acquittal process including any final reports are the
	responsibility of the Group.

- The grant payment will be made by 1 November 2016
- After the funds are deposited in to the Scouts Victoria bank account they will be managed via the Finance Team and allocated to the group accordingly
- Scouts Victoria will issue the CBA a tax-deductible invoice as required
- Local media/promotion may be organised by CBA and/or group
- The project must be completed within 12 months of receiving the funds
