WHO CAN APPLY?

- have a minimum of 40% volunteers working for your organisation;
- be a not-for-profit organisation;
- have an Australian Business Number (ABN) or be willing to provide a Statement by Supplier Form;
- have an account with an Australian financial institution in the name of the organisation applying.

FUNDING AMOUNT

The minimum grant amount is \$1,000.

The maximum grant amount is \$5,000.

APPLICATION PROCESS

STEP 1: Please complete the "Expression of Interest" form (EOI) and email to peta.murphy.mp@aph.gov.au or deliver to 37 Playne St, Frankston.

STEP 2: The Dunkley Community Committee will then assess all the received EOI forms and provide me with recommendations on which projects to proceed with. From these recommendations, I will then invite the selected applicants to submit a formal on-line application.

SUCCESSFUL APPLICATIONS

Successful applicants must complete their projects by 30 June 2025.
