It aims to spark excitement and aspiration so every Cub leaves wanting to become a Scout and dreaming of attending their own Jamboree in three years' time. The Cub Scout Experience plays a vital role in Victoria's retention strategy, inspiring the next generation of young people to continue their Scouting journey.

#### Role Purpose

The General Manager - Program & Experience is responsible for designing and delivering a high-quality, age-appropriate program that introduces Cub Scouts to the excitement, challenge, and adventure of the Scout Section.

This is not a Cub Scout program; it is a Scouting experience designed to showcase what comes next, providing Cubs with hands-on opportunities to explore the skills, teamwork, and independence that define the Scout Section.

#### **Primary Responsibilities**

- Design and coordinate the Cub Scout Experience program for both day and overnight participants.
- Develop an activity schedule that highlights the adventure and spirit of Scouting through fun, challenge, and teamwork.
- Ensure all activities align with Scouting's educational outcomes and the SPICES framework.

- Collaborate with Jamboree activity teams to allow Cubs to participate in selected Scout-level activities in a supported way.
- Coordinate the entertainment and evening components of the overnight experience, ensuring inclusivity and age suitability.
- Work with the Logistics and Campsite Operations team to ensure smooth transitions between activities.
- Liaise with the Catering and Hospitality team to integrate mealtimes and routines within the daily schedule.
- Develop and oversee risk assessments and safety documentation for all program activities.
- Encourage Rovers and Venturers to take active roles in program delivery as mentors and role models.
- Provide regular updates and progress reports to the Director Cub Scout Experience.
- Contribute to post-event evaluation and the AJ2028 final report.

- Enthusiastic and passionate about Cub Scouts and their progression to the Scout Section.
- Inclusive and collaborative in approach, valuing both youth and adult input.
- Committed to creating a fun, safe, and adventurous Scouting experience.
